Statement of intent

At Park View Primary Academy we target the use of Pupil Premium Grant funding to ensure that our disadvantaged pupils receive the highest quality of education to enable them to become active, socially responsible citizens of the future. We recognise that disadvantaged children can face a wide range of barriers which may impact on their learning.

Our ultimate objectives are to:

- ✓ Remove barriers to learning created by poverty, family circumstance and background
- ✓ Narrow the attainment gaps between disadvantaged pupils and their non-disadvantaged counterparts both within school and nationally
- ✓ Ensure ALL pupils can read fluently and with good understanding to enable them to access the breadth of the curriculum
- ✓ Develop confidence in their ability to communicate effectively in a wide range of contexts
- ✓ Enable pupils to look after their social and emotional wellbeing and to develop resilience.
- ✓ Access a wide range of opportunities to develop their knowledge and understanding of the world

Achieving our objectives:

In order to achieve our objectives and overcome identified barriers to learning we will:

- Provide all teachers with high quality CPD to ensure that pupils access effective quality first teaching
- Provide targeted intervention and support to quickly address identified gaps in learning including the use of small group work, 1:1 tuition

- Target funding to ensure that all pupils have access to trips, residential, first-hand learning experiences
- Provide opportunities for all pupils to participate in enrichment activities including sport
- Provide appropriate nurture support to enable pupils to access learning within and beyond the classroom

This is not an exhaustive list and strategies will change and develop based on the needs of individuals.

Key Principals:

We will ensure that effective teaching, learning and assessment meets the needs of all pupils through the rigorous analysis of data. Alongside academic support, we will ensure that those pupils who have social, emotional and mental health needs will access high quality provision from appropriately trained adults.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2022 to 2023 academic year.

<p>Support and CPD from DoLs and SLT in reading, phonics, writing, maths and Reading Enhanced curriculum. Both at Trust and Academy level.</p> <p>Work in books is better quality, continuity in working policies, better planned lessons focussing on historic and future learning. Lessons are more progressive and tailored to the children's needs. All classes using the TfW approach following 2 INSET days and academy has had positive visits from trainer and the Core team with responsibility for writing. CPD in all areas given to all staff during staff meeting times.</p>
<p>Support received from EP and Director of Phonics. Staff have accessed Launchpad CPD and purposeful assessments have been completed.</p> <p>Purchase of Phonics Tracker across KS2 has enabled staff to be specific when identifying individuals' gaps with phonics.</p>
<p>RAG meetings with class teacher and SLT show that teachers are considering and overcoming barriers more effectively. SDI is developing as a strategy across the academy to ensure gaps in learning are closed quickly. DoL support in every class for varied subjects has raised standards of teaching and learning. Launchpad and Phonics Tracker being used to support teachers' interventions.</p>
<p>Pupils struggling to access school encouraged to attend breakfast club.</p> <p>Breakfast club cost kept to a minimum to allow all pupils to attend.</p>
<p>Fortnightly meetings with Attendance Officer and HoA/Safeguarding leads in place.</p> <p>Attendance is celebrated in weekly assemblies.</p>
<p>Y5 and Y6 attended a residential at Dallowgill where they experienced a range of environmental and outdoor activities. They also experienced being away from home and organising themselves for meals etc which supported their life skills.</p>
<p>Thrive assessments are developing. Timetabling to support pupils needing SEMH support. Continued CPD for Thrive practitioners to remain licensed and up-to-date with pedagogy and practice.</p>
<p>Referrals to Speech and Language therapist made where needed.</p> <p>Oracy training with Voice 21 was attended by staff who have raised the profile in school.</p> <p>Curriculum project undertaken by Oracy Leader.</p>
